
Usage

The Nuclespot Mini Spot Alpha Ionizer neutralizes static charges by providing ionized air to affected objects. It is designed for use in space limited applications.

Installation & Operation

Position the Mini Spot 1" to 1-1/2" away from the static charged object. Maintain this positioning by mechanical or manual means. Ensure that there are no obstructions between the grid of the Mini Spot and the intended object.

The Mini Spot works best when used with the provided ground wire. To simplify installation, a hole has been added on the circumference of the Mini Spot to accommodate the ground wire (model 5061).



To ensure maximum static removal efficiency, the Mini Spot must be replaced annually regardless of use. The replacement date is one year after the date manufactured (printed on each Mini Spot). NRD will remind customers of the replacement date.

Trouble Shooting Guide

Symptom	Probable Causes	Corrective Action
Static charges are not removed	Mini Spot is too far from object	Reposition Mini Spot within one inch of object
	Mini Spot is out of date and needs replacement	Call NRD for Mini Spot replacement
	Obstruction exists between the Mini Spot and the object	Remove the obstruction



Installation

 Attach ring terminal at the end of the ground wire to ground potential. (Attachment hardware is not provided). Ensure that the process machinery is also grounded. Verify that the ionizer and machinery are grounded by having them checked by a qualified electrician.

Maintenance

- Maintenance is not required.
- To ensure maximum static neutralization, the Nuclespot® model P-2042 must be replaced once a year regardless of usage.
